- 1. I am an attorney at Hausfeld LLP, which represents the Direct Purchaser Plaintiffs class ("DPPs") in the above-captioned action. I submit this declaration in support of the DPPs' Motion for Order Permitting and Confirming Updated Opt-Out Report. I make this declaration based on my personal knowledge and, if called, could testify hereto the following information.
- 2. Pursuant to the Court's Order, the deadline to submit an opt-out request seeking exclusion from the DPPs' Litigation Class was June 12, 2023. *See* ECF No. 3024.
- 3. On June 23, 2023, I received an email from JND Legal Administration LLC ("JND"), the DPPs' Notice Administrator, regarding a late request for exclusion from Performance Food Group, Inc. ("PFG").
- 4. JND included PFG's delayed request for exclusion in its original opt-out report, filed on June 26, 2023. *See* ECF No. 3082-1, Ex. D; Ex. E at 108-12.
- 5. On June 27, 2023, I received a declaration from PFGs' counsel, intended for inclusion in the pending Motion, attesting to the reason for PFG's delay.
- 6. On June 28, 2023, I received an email from JND explaining that counsel for ALDI, another Class member, had reached out to JND, claiming that ALDI had sent an opt-out request prior to the DPP Settlement deadline, but was not included in JND's opt-out list. *See* ECF No. 3082-1, Ex. D.
- 7. JND asserted that it had reviewed its records and did not find an opt-out request from ALDI. JND asked ALDI for any proof of mailing, which ALDI was unable to provide.
- 8. On June 30, 2023, I received an email from JND regarding a late request for exclusion from Krasdale Foods, Inc. ("Krasdale") and Wegmans Food Markets, Inc. ("Wegmans").
 - 9. On July 10, 2023, I received declarations from Krasdale and Wegmans'

- 10. On July 10, 2023, I called Ashley Bauer at Latham & Watkins, counsel for StarKist Co. ("StarKist") and Dongwon Industries, Inc. ("DWI" or "Dongwon"), regarding ALDI's opt-out request. During the phone conversation, Bauer informed me that Big Lots and Weis Markets ("Weis") also claimed to have submitted opt-out requests that were not reflected in JND's opt-out list.
- 11. Following the phone conversation, Bauer e-mailed me a list of parties—ALDI, Big Lots, Ingles Markets, Inc. ("Ingles"), Krasdale, Sysco Corp. ("Sysco"), Target Corp. ("Target"), Wegmans, and Weis—that have existing settlement agreements with StarKist and Dongwon and are required therein to opt-out of the Class with respect to StarKist and Dongwon.
- 12. In the e-mail, Bauer attached opt-out request letters from ALDI, Big Lots, and Weis. Bauer also attached two Orders from the Court, granting joint motions to dismiss with respect to Target (ECF No. 1886) and Sysco (ECF No. 1884). Bauer did not assert that either Target or Sysco had ever sent an opt-out request to JND nor has JND received one.
- 13. On July 11, 2023, I reached out to JND regarding the opt-out requests Bauer asserted were sent by Big Lots and Weis but not received. JND responded that it had double-checked its mail room and did not receive Big Lots' purported letter. JND asked Big Lots' counsel for proof of mailing, which Big Lots was unable to provide.
- 14. JND explained that it had received Weis's letter on the date attested to but did not consider the letter a request for exclusion because Weis did not "mention or request exclusion or opting out" therein.
- 15. On July 11, 2023, I e-mailed Bauer regarding whether Ingles had submitted an opt-out request as JND had not received one. Bauer had included Ingles

- 16. On July 20, 2023, Bauer e-mailed me a delayed exclusion request letter from Target, attesting to Target's settlement agreement with StarKist and Dongwon. The letter was dated July 18, 2023.
- 17. DPPs do not object to the requests for exclusion from any of the parties listed by StarKist's counsel, except Ingles. All noted parties, with the exception of Ingles, are included in DPPs' updated opt-out list.
- 18. Attached as Exhibit A is a true and correct copy of the updated opt-out report by JND.
- 19. Attached as Exhibit B is a true and correct copy of the Declaration of Roxann E. Henry, counsel for PFG.
- 20. Attached as Exhibit C is a true and correct copy of PFG's opt-out letter, dated June 21, 2023.
- 21. Attached as Exhibit D is a true and correct copy of PFG's updated optout letter, dated June 26, 2023.

DECLARATION OF ATTORNEY FOR PFG, ROXANN E. HENRY

I, Roxann E. Henry, do hereby make this declaration at the request of Christopher Lebsock of Hausfeld LLP counsel for the Direct Purchaser Plaintiffs, regarding In re Packaged Seafood Products Antitrust Litigation, MDL No. 2670 and declare upon personal knowledge the following:

On or about June 3, 2019, Performance Food Group (PFG) entered into a settlement agreement with Starkist Co.and its related entity Dongwon Industries Co.Ltd. (Starkist) regarding allegations of price fixing packaged seafood products (Starkist Settlement). The terms of the agreement required PFG on behalf of itself and all its then current or prior subsidiaries to opt out of class action litigation regarding covered claims, which would include the claims in the above-referenced litigation.

PFG subsidiaries currently include Reinhart entities, which also would have purchased relevant products in the relevant time frame. As PFG acquired the Reinhart entities after the execution of the Starkist Settlement, the Reinhart entities were not part of the agreed-opt-out requirement.

I first learned of notice of a litigation class certification requiring opt-outs in this matter in a communication from Latham & Watkins LLP, counsel for Starkist, on May 21, 2023, which I forwarded to Mr. Eakin, an in-house counsel with PFG, the same day, noting the issue of the need for a determination of whether the Reinhart entities should opt out. I also spoke that day with Mr. Eakin. He advised me it would be necessary to research and contact an attorney who had represented the Reinhart entities prior to their acquisition in connection with Reinhart purchases of various foods alleged to have been price-fixed because Reinhart might have had a separate pre-acquisition settlement agreement requiring opt-out.

I also communicated with Mr. Lynch at Latham & Watkins, noting that there would be a question regarding the Reinhart entities. Mr. Lynch expressed that his client was open to considering a separate settlement with those entities.

Mr. Billings, the attorney who had previously represented the Reinhart entities, responded to Mr. Eakin on June 16, 2023 explaining that there was no evidence that Reinhart entered into any separate settlement with any of the Tuna Defendants.

I communicated with Latham & Watkins on June 21, 2023. Immediately upon recognizing that the exclusion deadline had passed, I also called JND Legal Administrator and sent the opt-out letter on June 21, 2023. The Administrator confirmed receipt of the letter on June 21, 2023. Thus, the deadline was missed by seven business days.

After conferring with Latham & Watkins and counsel for the Direct Plaintiffs, I revised the opt-out letter for greater clarity. It is attached.

Upon penalty of perjury I declare that the foregoing is true and correct.
